While renovating his house in 2008 Duane placed a premium on time rather than "safety" which resulted in the amputation of three fingers and the thumb on his dominant hand. In his haste to "get the job done" he knowingly cut a dangerous corner that caused the injury. Duane's first response to his injury was "I want a Do-over!" Realizing that the mental trauma and anguish far surpassed the physical recovery of his injury he began to look for ways to warn others of the "close calls" or "near misses" they may have ignored. The Real Impact of Distracted Driving Take Action. Prevent Distraction.

Is your Safety Committee aware that distraction-related road user injuries and fatalities are fast overtaking all other forms of road related injuries and death both on-the-job AND off-the-job? Presented by Drop It And Drive™ (DIAD), a Traffic Injury Research Foundation education program, focused on preventing distraction-related road user injuries and fatalities. DIAD uses science and real stories to explain and demonstrate what behaviours increase risk and why, as well as sharing stories of the real consequences of these behaviors. 'Take Action. Prevent Distraction.' is a call to action for workplaces, road users, and communities to put a stop to distraction-related incidents through changing behaviours.
